<b>GUIDING POLICY</b>	Support for rural communities living in areas with water scarcity in Zhytomyr region, Ukraine. The introduction of integrated development programs at the regional and local level within the Global Water Solidarity Platform (GWS) and the ART Initiative. Mobilization of resources to ensure access to water and sanitation, water management and search for a system to long term financing of projects on water at the local level. Educational activities to raise awareness among the population. Implementation of measures that protect public health and prevent the incidence of water-borne diseases.
<b>DURATION</b>	12 months In case of force majeure and based on the experience gained under implementation of similar projects, the project activity may be extended by 1-2 months.
<b>PROJECT SUMMARY</b>	<p>Assistance in the implementation of the pilot infrastructure project on water and sanitation. The project aims to ensure sustainable balanced development of decentralized drinking water supply, water discharge and sewage treatment in the village of Norinsk, Ovruch district of Zhytomyr region, to meet the needs of consumers, especially people, in the water of guaranteed quality, to solve the problem related to the lack of sanitation in rural areas, to reduce the negative impact on the environment.</p> <p>Partial repair of water supply systems, partial reconstruction of treatment facilities, restoration of artesian well, replacement of equipment, channelling of households to existing water pipes.</p>
